EASEMENT AGREEMENT

Private Easement Individual(s) as Grantor

The undersigned SUSAN K. LEWIS and JANET A. SHOBER, as Tenants in Common, herein after referred to as the ("Grantor") for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, does hereby grant and convey unto QWEST CORPORATION, a Colorado corporation, herein after referred to as the ("Grantee"), whose address is 1801 California St., Suite 5200, Denver, CO 80202, and its successors, assigns, affiliates, lessees, licensees, and agents, a perpetual non-exclusive easement to construct, modify, add to, maintain, and remove such telecommunications facilities, and other appurtenances, from time to time, as Grantee may require upon, over, under and across the following described property situated in the County of Sheridan, State of Wyoming, which Grantor owns or in which Grantor has an interest ("Easement Area"), to wit:

A strip of land 16.00 feet wide, situated in the Northwest Quarter (NW1/4) of Section Six (6), Township Fifty Five (55) North, Range Eighty Three (83) West of the 6th P.M. and lying within a parcel of land described in the Quitclaim Deed recorded in Sheridan County, Wyoming on November 2nd, 2010 as Instrument No. 682947, in Book 519, Page 792. Said strip being more particularly shown on Illustration "A" and described as beginning at the northeast corner of the property and proceeding in a southeasterly direction, contagious with and parallel to the west right-of-way line of County Road No. 139 (East Ridge Road), a distance of 1650 feet (+/-); all of said strip being north of that portion of County Road No. 139 presently known as Peno Road.

Grantor further conveys to Grantee the right of ingress and egress to and from the Easement Area during all periods of construction, maintenance, installation, reinforcement, repair and removal over and across Grantor's lands with the right to clear and keep cleared all trees and other obstructions as may be necessary for Grantee's use and enjoyment of the Easement Area.

Grantee shall indemnify Grantor for all damages caused to Grantor as a result of Grantee's negligent exercise of the rights and privileges herein granted. Grantee shall have no responsibility for environmental contamination, which is either pre-existing or not caused by Grantee.

Grantee agrees to pay all physical damage to any landscape, structural or other improvements that may be caused by construction, maintenance, operation, replacement or removal of its facilities.

Grantor reserves the right to occupy, use and cultivate the Easement Area for all purposes not inconsistent with the rights herein granted.

Grantor covenants that Grantor is the fee simple owner of the Easement Area or has an interest in the Easement Area. Grantor will warrant and defend title to the Easement Area against all claims.

Grantor hereby covenants that no excavation, structure or obstruction will be constructed or permitted on the Easement Area and no change will be made by grading or otherwise that would adversely affect Grantee's use and enjoyment of the Easement Area.

The rights, conditions and provisions of this Agreement shall run with the land and shall inure to the benefit of and be binding upon Grantor and Grantee and their respective successors and assigns.


