MEMORANDUM OF SURFACE **USE AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS:

Mary V. Hutton, a married woman of P.O. Box 4007, Sheridan, WY 82801 and Stella M. Barker, a married woman of P.O. Box 888, Sheridan, WY 82801 (the "Owners"), and J.M. Huber Corporation, a New Jersey corporation of 1050 17th Street, Suite 800 Denver, CO 80265 (the "Lessee"), entered into that certain Surface Use Agreement dated October 11, 2002, that was amended by the parties on August 18, 2008 (the "Agreement") covering the real property located in Sheridan County, Wyoming, more particularly described on Exhibit A and incorporated herein by this reference (the "Lands").

Huber owns oil and gas leases which cover the Lands. Pursuant to those leases Huber conducts coalbed methane exploration, development and production operations. Pursuant to the Agreement Owner and Huber have agreed upon, among other things, the damages to be paid by Huber arising from its use of the surface of the Lands and the manner of locating wells for the production of coalbed methane and the locating of roads, pipelines, power lines and surface equipment related to such wells.

This Memorandum is executed by Owner and Huber and recorded in Sheridan County, Wyoming to serve as notice of the existence of the Agreement. The parties acknowledge they are bound by all the terms and conditions of the Agreement.
