KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned (whether one or more)

EASEMENT

David C. Morgan and Pearl Morgan
(summarized) (husband and wife) of Sheridan County, State of Wyoming, for a good and valuable consideration, the receipt whereof is hereby acknowledged, do hereby convey and warrant unto Sheridan-Johnson Rural Electrification Association, a Wyoming corporation, whose post office address is Sheridan, Sheridan County, Wyoming, and to its successors or assigns, the right to enter upon the lands hereinafter described, situate in the County of Sheridan, State of Wyoming, and more particularly described as follows, to-wit:

SW1/4 Section 12, Township 56 North and Range 64 West.

The undersigned hereby relinquish(es), release(s) and waive(s) all rights, distributive share or homestead interest under and by virtue of the homestead exemption laws of the State of WYOMING to the extent necessary to permit the Association the free enjoyment of the rights herein conferred; and to place, construct, operate, repair, maintain, relocate and replace thereon and therein and to include in addition thereto such rights upon all streets, roads and highways abutting said lands an electric transmission or distribution line or system, and to license, permit or otherwise agree to the joint use or occupancy of the line or system by any other person, association, or corporation for electrification or telephone purposes, and to time to time all dead, weak, leaning or dangerous trees that are tall enough to strike the wires thereof in falling.

In granting this easement it is understood that the location of the poles will be such as to form the least possible interference to farm operations, so long as it does not materially increase the cost of the construction.

The undersigned agree(s) that all poles, wires and other facilities, including any main service entrance equipment, installed on the above-described lands at the Association's expense shall remain the property of the Association, removable at the option of the Association, upon termination of service to or on said lands.

The undersigned covenants that he (or they) is (or are) the owner(s) of the above-described lands and that the said lands are free and clear of encumbrances and liens of whatsoever character except those held by the following persons:

It is further understood that, wherever necessary, words used in this instrument in the singular shall be construed to read in the plural and that words used in the masculine gender shall be construed to read in the feminine.
