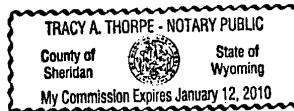
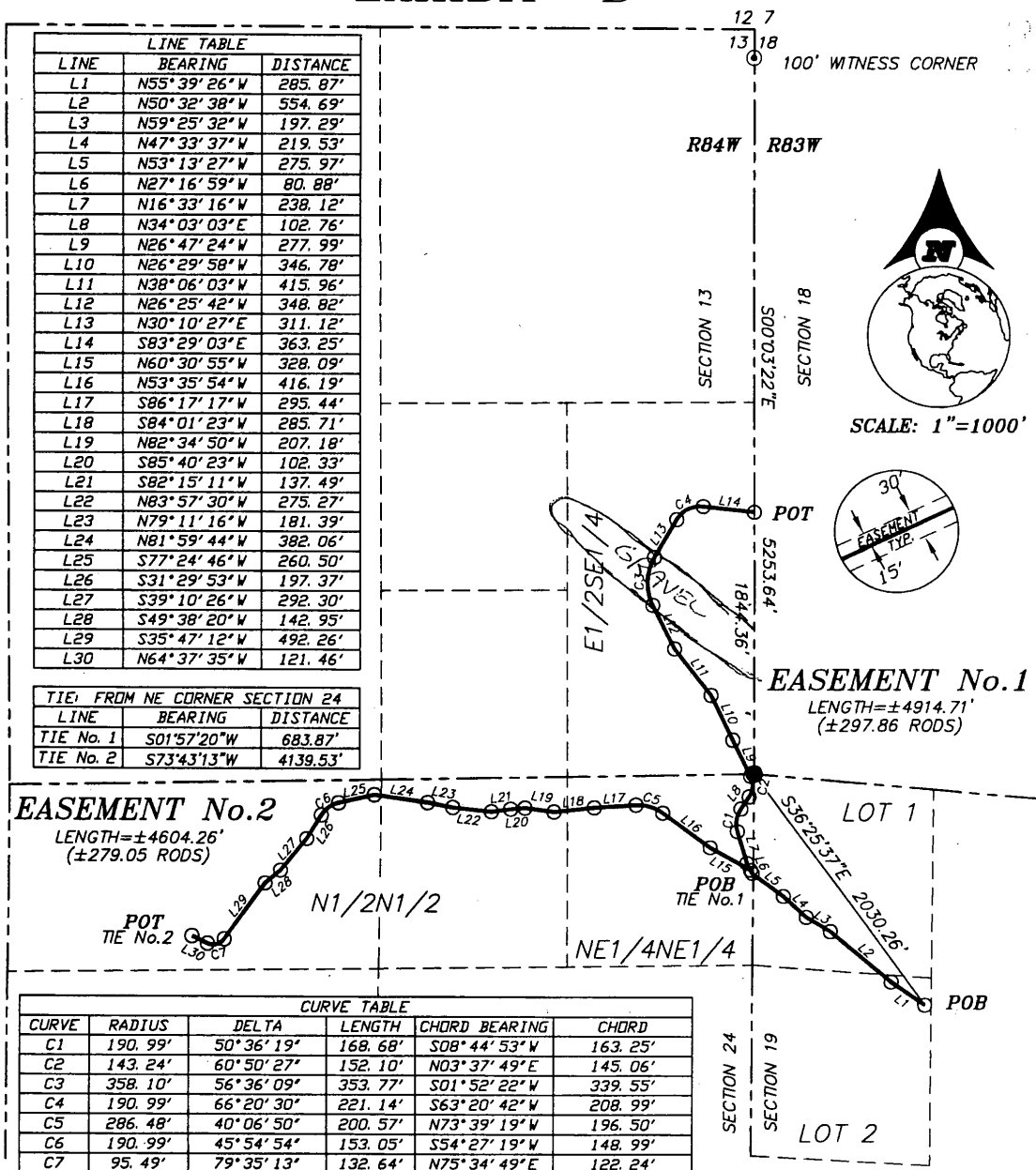

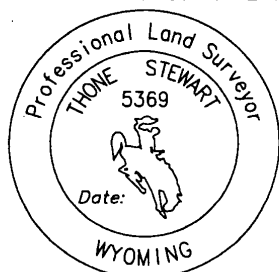
BASIS TABLE
