DEDICATION OF UTILITY EASEMENTS FOR PUBLIC USE

This Dedication for Public Use is made effective the 7th day of March, 2006, by DSB INVESTMENTS, INC., a Wyoming corporation whose address is 247 Wildcat Road Sheridan, Wyoming 82801 ("Grantor") in favor of the public for public utility purposes, and accepted by SHERIDAN COUNTY, WYOMING though the Board of County Commissioners for Sheridan County ("Grantee").

RECITALS

- A. The Grantor created the Indian Paintbrush Subdivision, as more particularly described and laid out in that certain plat prepared by MC2 Engineering, P.C., (the "Plat") approved by the County Commissioners of Sheridan County on the 7th day of March, 2006, and recorded in the Office of the County Clerk of Sheridan County as Document No. 534944 on March 22, 2006, in Drawer I, Plat No. 4, herein called the "Plat".
- B. The Plat describes and shows certain utility easements within Indian Paintbrush Estates.
- C. The Grantor wishes to make clear that those easements are dedicated for use by utility providers for the purpose of providing utilities to the public.
- D. Sheridan County, though the Board of County Commissioners of Sheridan County, wishes to accept such dedication and agrees that the Plat should be corrected to reflect the dedication such utility easements.

DEDICATION FOR PUBLIC USE

NOW, THEREFORE, for good and valuable consideration, including the mutual promises and covenants contained herein, it is agreed by and among the parties as follows:

1. Grant of Easement

Grantor does hereby grant and convey to Grantee, and dedicates for use by public utility providers forever, an easement for the installation, maintenance and repair and replacement of public utilities, including but not limited to water and sewer services, power and gas service providers, phone services and the like, to provide utility services for the benefit of the public, both within and beyond the lands described in the Plat. The easements are located on Lots 1-16 of the Indian Paintbrush Subdivision, Sheridan County, Wyoming, and more particularly described and shown on the Plat.

2. <u>Terms of Use.</u>

Providers of all such public utilities shall have the perpetual non-exclusive right to use the utility easements described and shown on the Plat.

3. Acceptance.

Grantee hereby accepts the dedication of the above-described utility easements as described on the Plat and herein.
