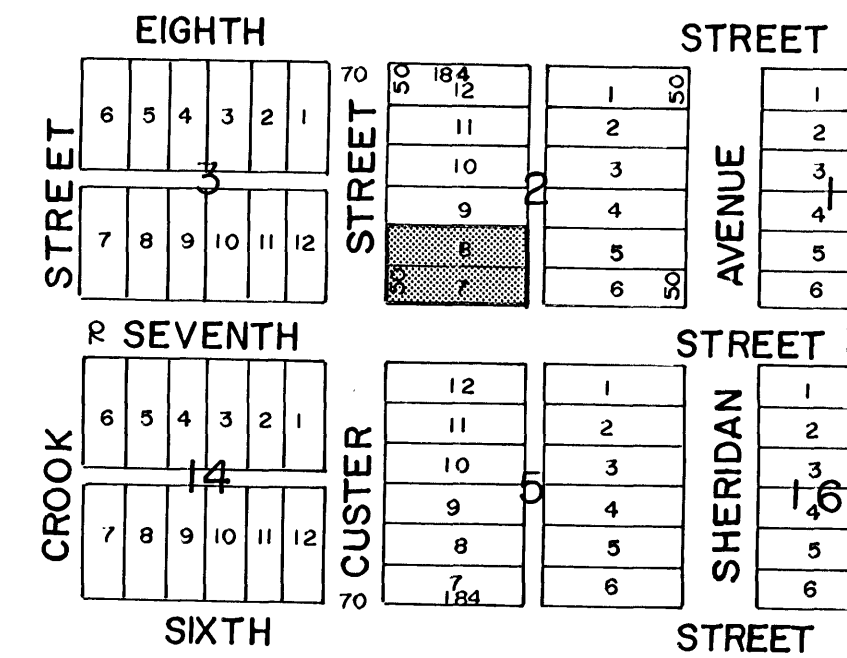

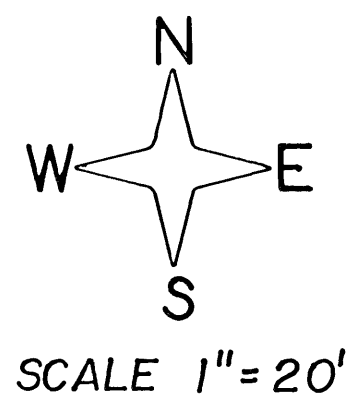

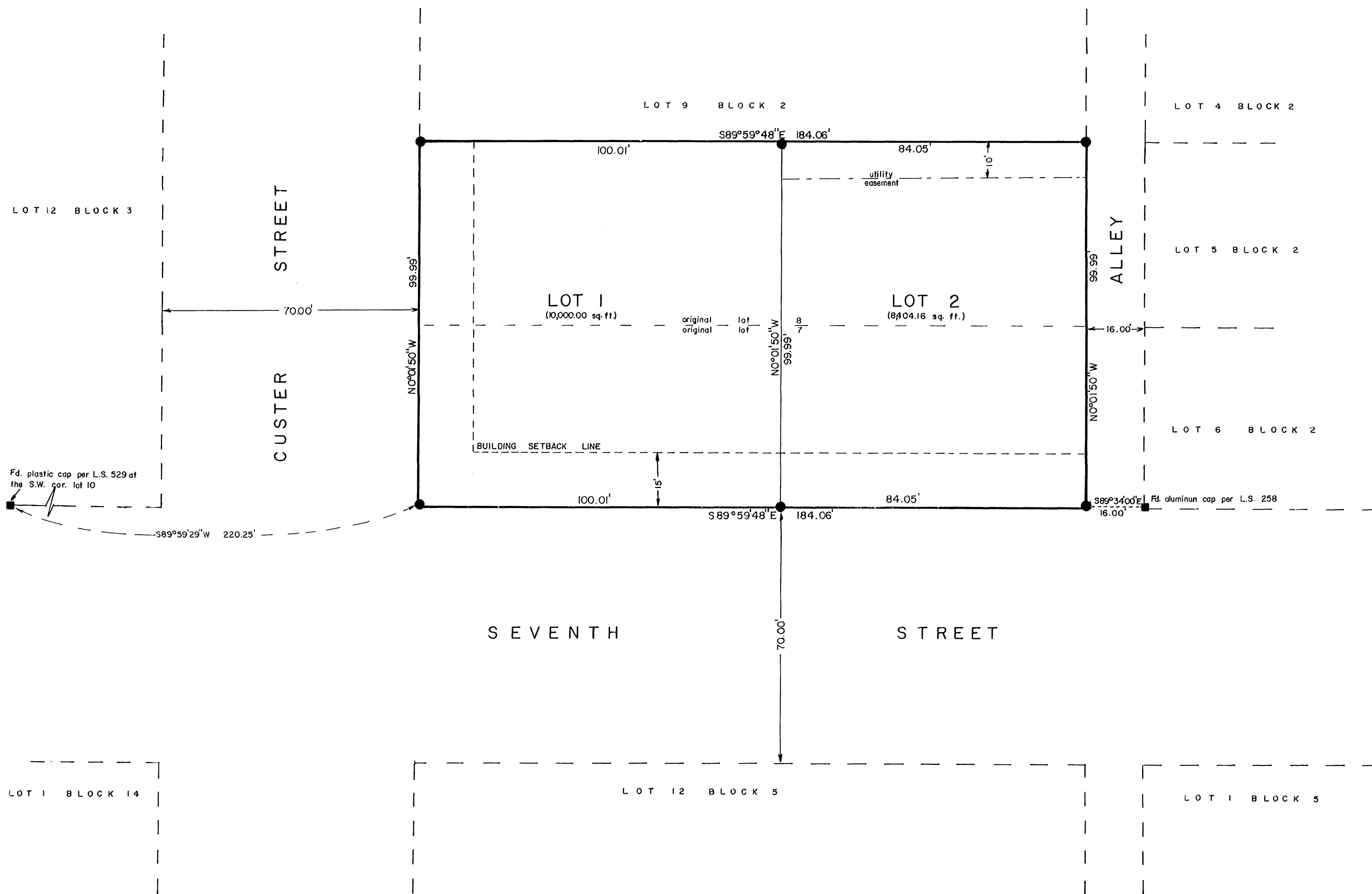
LOCATION MAP

CERTIFICATE OF DEDICATION
