
The LOT SO VACATED is as follows:



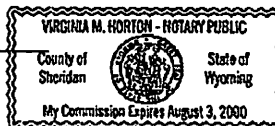
