FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS AND EASEMENTS FOR WESCO BUSINESS PARK

The DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS AND EASEMENTS FOR WESCO BUSINESS PARK recorded in the Sheridan County Clerk's office on August 415, 2004 in Book 455 at Page 469 (herein referred to as the "Covenants") is hereby amended, as set forth hereafter.

WHEREAS, the undersigned WESCO, LLC, a Wyoming limited liability company, was the "Declarant" of the Covenants and currently owns more than Seventy Five Percent (75%) of the Lots in the Subdivision, and said WESCO, LLC, has by proper vote and procedure, declared that this First Amendment To Covenants should be executed and recorded against the Subdivision.

NOW THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the undersigned amend the Covenants as follows:

 No roof of any building that is constructed within the Subdivision shall use metal for the roofing material. The term "roof" shall not include the soffit or fascia of any such building.

All the rest and remainder of the Covenants not specifically amended herein is confirmed and ratified and shall remain unchanged by this instrument.
